• This report was received and approved at the Oct. 2 meeting.

#### Organizational Filings

- Application to CT Dept of Consumer Protection, and received Charitable Organization Registration Exemption Verification effective 9/6/2013. This documents that CT DCP recognizes that we are a Charitable Organization that does not receive more than \$50K/yr. in donations. This exemption does not expire, as long as we are below the \$50K/yr. threshold. Therefore, the Treasurer of GSC will not need to file the State Annual Charitable Organization Registry, saving \$50/yr.
- CT Secretary of State Incorporation Reports completed for the years 2012 and 2013.
- Submitted form to update the designated Agent and Address for the Society (9/16/2013).
- Form 990-in preparation- needs to be approved by the BOD for filing prior to Nov. 15, 2013 for FY July 1, 2012-June 30, 2013. Will be emailed to BOD members for approval prior to filing.

#### Treasury Simplification

Upon the recommendation of John Purtill, I contacted the Treasurer of the Geological Society of New Hampshire (GSNH) to discuss their accounting system. GSNH have treasury activities similar to our Society, and have been using MS Excel, but are considering a switch to Quicken. The GSNH treasurer prepares quarterly reports for their Board. He uses Excel to keep a running ledger, similar to what John Purtill recommended for us, with descriptive categories for each entry that can be simplified into income and expense types for reporting purposes. The GSNH keeps membership records separate from the treasury, so the treasurer does not keep track of renewals etc, beyond the financial transactions.

I am proceeding with Excel, and will meet again with John Purtill to have him review our 990 tax filing this month.
